

FORMALIZATION AND REGISTRATION OF MSES

Hello colleagues,

As you are aware, the Authority operationalized the office of the Registrar as stipulated under Section 4 of MSE Act of 2012. The main function of the Office of the Registrar is registration of MSEs and maintenance of a comprehensive and dependable database of registered MSEs in a bid to formalize the MSE sector as well as to provide statistics to the government to budget and create policy interventions that are tailor-made to the needs of MSEs. The Authority targets to register and create a database of MSEs in Kenya factoring their biodata, demographics, sectors & economic activities.

A large proportion of MSMEs in most developing Countries are informal which means that often they have little or no financial resources, and face tremendous barriers in accessing conventional financial institutions for start-up businesses due to their poverty and lack of collateral assets. This financial challenge is common in our Country particularly affecting entrepreneurs among rural women and other socially disadvantaged groups. Therefore, the process of formalization and resilience is crucial in development of MSEs based on the Leaving No-One Behind principle, central to the 2030 Agenda.

The Authority developed an online registration system (registrar.msea.go.ke) that is geared towards enhancement of formalization of the MSE sector in Kenya. The system was designed in line with MSE policies and national strategic documents that advocate for the recognition and development of Individual MSEs, MSE associations and Umbrella Organizations. However, before the office became operational, most of the MSE Associations were registered by other Government Agencies hence the need of formalizing the sector to create one MSE data base.

It had been noted that lack of awareness of the operationalization of the Office of the registrar was one of the main challenge that had bedeviled the registration process, hence need of creating a robust and massive awareness of its operations and mandate to the MSEs.

The Authority has carried out various activities: - held several sensitization meetings with key stakeholders (MSEs, Area leadership, County Governments) on the importance of group formations through registration, created awareness on the importance of effective association's formation, linked registered groups to CIDCs within localities of the registered MSE Associations as well as issued machineries to support the MSEs.

These activities among others have contributed to the increase in registration numbers that the Authority has received. We are optimistic that with the establishment of MSE Development (hustlers) fund, we will have more MSEs turning up for registration. Thank you for your diligence in conducting the registration matters, we can do more, let's leverage on the ongoing Hustler fund hype and register more MSEs.

Creative Innovations

mong the MSMEs who were invited to exhibit and demonstrated creative innovation was Peter Maina a mechanical Engineer from Thika Welfare Association and co-founder of Gari Letu Fabricators Ltd.

The company is a joint venture of 5 mechanical engineers that teamed up and started manufacturing locally, low-cost maintenance manual Station Wagons intended for PSV services. The vehicle has a capacity of 4 passengers and runs on a motorcycle engine. To formally start operations, they are awaiting approval from Kenya Association of Manufacturers. They are also awaiting number plate registration and a letter from PSV and plan to continue manufacturing the station wagons and add four-wheel pickups, vans and trucks. The station wagon retails at Kshs. 450,000 inclusive of VAT. For more enquiries, kindly contact them on 0727553440.

Another MSE who demonstrated creative innovation was Dennis Bwire a cycle 3 KYEOP grant beneficiary who previously used to sell sweets in bus stops. So upon receiving the first tranche, he added stock of the sweets and continued with the business. Apart from selling sweets, Dennis is a self-taught electrician who manufactures extension cables and subwoofers from wood. This idea came about when the government of Kenya banned manufacturing of plastics, therefore he identified a niche and started manufacturing wood extension cables. He used to do it as a side hustle while still selling sweets. The extension cables have a capacity of holding water heater, refrigerator, and music speakers among others. He also makes home banks. Upon receiving the second tranche he added previous savings and boosted the extension cables business and up scaled his production. His workshop is located in Ruiru Kiambu County. His innovation has interested the media and he has been interviewed a couple of times.

ew Hope Community Based Organization in Mpeketoni was formed in 2016 and currently has a membership of 50 MSEs. The main aim of its formation was to ensure Economic Empowerment of its members, the community in Mpeketoni and the entire Lamu County. The CBO has invested in Cashew nuts value addition where they plan to employ around 70 casuals and provide market and better prices for approximately 6,000 farmers in Lamu County.

MSEA Lamu County office visited the CBO which recently acquired land with the support of the County Government and Agriculture Sector Development Support Programme (ASDSP) where they have constructed a warehouse. The CBO is sourcing for machinery and are working to raise partial funding for machines required for operations. MSEA has committed to support them in development and growth of agribusiness especially through value addition.

At the time, the institution was not only offering training to 250 students but had also created job opportunities for over 12 technical trainers. Currently, Mr. Joseph Mworia Thuranira, a Person Living with Disability

and the proprietor of the polytechnic has employed few people in the carpentry and dressmaking sector with the aim of reviving the institution. The MSEA Meru office is supporting him through market linkages to enable him enroll students and boost his financial capability.

The team has also linked him with the Kenya Industrial Estates for financial support.

Sunflower oil production at the Kariobangi Centre of excellence

aleb and Daniel Muthaka operate CM Oils and refineries out of the Kariobangi Centre of Excellence in Kenya. They press sunflower seeds to get natural oil. The oil has been examined and found to be free of contaminants and pollutants. The process of extracting the oils begins with winnowing and continues via sieving/washing, pressing, filtering, and packing. They market their goods on Jumia to Nairobi residents and businesses.

The leftovers after the extraction are used by CM Oils to create sunflower cake, which is then sold to farmers for use as cow fodder. The cost of oil is Kshs. 300 for 1 litre, Kshs. 1500 for 5 litres, and Kshs. 6000 for 20 litres.

who handed over the machinery to artisans are drawn from 17 Juakali associations that have been registered with the Registrar of Micro and Small Enterprises (MSEs).

The machines issued include; woodwork combination machines, woodwork routers, welding machines, vehicle diagnostic and electrical tool kits that will be used by mechanics, electricians, welders, plumbers

and carpenters among other artisans. Speaking during the handover event at Aldai Technical Training Institute, H.E The Deputy President Hon. Rigathi Gachagua called on the artisans to utilize the machinery to improve their workmanship and quality of their products to fulfill the demands consumers.

"Skilled labour and self-employment is the way to spur entrepreneurship among young people and inculcate good production practices for made in Kenya products to enlarge market opportunities," he said.
